AN ORDINANCE RE-ALIGNING THE AMOUNT OF FOUR HUNDRED NINETY FIVE THOUSAND PESOS (PHP 495,000.00) FROM THE "ADVERTISING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "REPAIR AND MAINTENANCE OF MOTOR VEHICLES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2014.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica duly seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the budget of the Office of the Sangguniang Panlungsod for the "Advertising Expenses" to "Repair and Maintenance of Motor Vehicles" as indicated above covered by Annual Budget for CY 2014.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Four Hundred Ninety Five Thousand Pesos (PhP495,000.00) for the "Repair and Maintenance of Motor Vehicles" under the budget of the Sangguniang Panlungsod Office for Calendar Year 2014;

Section 2. The above-mentioned amount of Four Hundred Ninety Five Thousand Pesos (PhP495,000.00) shall be re-aligned from the "Advertising Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2014;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.
