AN ORDINANCE GRANTING ADDITIONAL FINANCIAL ASSISTANCE AND TRAINING FUNDS TO EACH REGIONAL AND METROPOLITAN TRIAL COURT JUDGES, THEIR RESPECTIVE CLERKS OF COURTS, CITY AND ASSISTANT CITY PROSECUTORS, PROVINCIAL AND ASSISTANT PROVINCIAL PROSECUTORS AND PUBLIC ATTORNEY'S OFFICE LAWYERS AND PROVIDING FUNDS THEREOF.

WHEREAS, ensuring the speedy and orderly administration of justice is the duty and responsibility of everyone in government – not just those connected with the judiciary.

WHEREAS, the effective administration of justice is the bedrock upon which our democracy rests which is why under Section 458 (1) (xi) of Republic Act No. 7160, local government units are allowed to provide for additional allowances and other benefits to judges, prosecutors, and other national government officials stationed in or assigned to a particular city of municipality.

WHEREAS, the judges and clerks of court of the Regional Trial Court and of the Metropolitan Trial Court, as well as the provincial and city prosecutors and public attorneys assigned to the City of Bacoor have proven time and again their whole-hearted and competent support of the city government's various campaigns against the spread of criminality.

WHEREAS, while it is true that the city government has already been providing allowances and other forms of financial support to the presiding judges of the Regional Trial Court and of the Metropolitan Trial Court Judges, to their respective Clerks of Court, to the City and Assistant City Prosecutors, and to the city's Public Attorneys, the said amount has become insufficient to defray their various personal expenses given the effects of inflation on the prices of commodities. The said amounts also does not include financial support that would allow the said judges, prosecutors, and court personnel to attend trainings that would invariably improve their knowledge and capabilities to the benefit of litigants in the City of Bacoor.

BE IT ENACTED by the Sangguniang Panlungsod of the City of Bacoor City, in session duly assembled, that:

SECTION 1. Monthly Allowances. The following amounts are hereby granted and approved in the form of monthly allowances in favor of the following officials of the Regional Trial Court, the Metropolitan Trial Court, the Office of the Provincial Prosecutor, the Office of the City Prosecutor, and the Public Attorneys' Office, respectively:

SECTION 3. Release of Monthly Allowances and Training Budget Support. -- Subject to availability of funds, the said monthly allowances and training budget support shall be released by order of the City Mayor upon the written recommendation of the Executive Judge of the Regional Trial Court, the Executive Judge of the Metropolitan Trial Court, the City Prosecutor of the City of Bacoor, the Head of the Public Attorney's Office in the City of Bacoor, and by the Provincial Prosecutor respectively. The recommendation of the court officials mentioned above with regard the monthly allowances shall be based on the performance of the person/s in whose favor the said allowances or training budget support shall be released and shall only pertain to the officials under their respective offices. On the other hand, the recommendation of the said court officials with regard the release of the training budget support shall be based on the necessity of attendance in any seminar or training that would help improve the competence or knowledge of the personnel concerned. In no instance shall the training budget support shall be used for trainings or seminars not approved by the Supreme Court or by the Department of Justice or for expenses that may be considered ostentatious or luxurious. **Provided:** that the City Mayor shall have the option of over-ruling the recommendation of the court officials enumerated above if he believes that doing so shall redound to the benefit of the general public or to the efficient administration of justice.

SECTION 4. Budgetary Appropriation. -- The funds required to make the above-mentioned allowances and training budget support shall be taken from the available and/or disposable funds of the City of Bacoor as may be permitted by law or under pertinent regulations of the Department of Budget and Management (DBM).

SECTION 5. Effectivity Date. -- This Ordinance shall take effect upon its approval and after it has been published at least once in a newspaper of general circulation in the Province of Cavite.

SECTION 6. Separability. -- The invalidation of any provision of this Ordinance by a competent court of law shall not affect the validity of the remaining provisions hereof not affected by such judicial determination.
