AN ORDINANCE RE-ALIGNING THE AMOUNT OF FOUR MILLION FIVE HUNDRED SIXTY NINE THOUSAND SIX HUNDRED PESOS (PHP 4,569,600.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OFFICE SUPPLIES EXPENSES" AND THE "OTHER SUPPLIES (PRINTING) EXPENSES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2015.

WHEREAS, submitted for review and approval are the proposed re-alignment of funds under the "Other Maintenance and Operating Expenses" to "Office Supplies Expenses" and "Other Supplies (Printing) Expenses" under the budget of the Office of the Sangguniang Panlungsod covered by the Annual Budget for Calendar Year 2015;

WHEREAS, the funds to be re-aligned shall no longer be used by the Office of the Sangguniang Panlungsod for the "Other Maintenance and Operating Expenses" considering that there are sufficient available funds to finance the operating expenses of the said office;

WHEREAS, there is a need to re-align the amount of Four Million Five Hundred Sixty Nine Thousand Six Hundred Pesos (Php4,569,600.00) from the "Other Maintenance and Operating Expenses" to the "Office Supplies Expenses" and "Other Supplies (Printing) Expenses" under the Office of the Sangguniang Panlungsod, to wit:

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica duly seconded by all the members present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the budget of the Office of the Sangguniang Panlungsod for the "Other Maintenance and Operating Expenses" to "Office Supplies Expenses" and "Other Supplies (Printing) Expenses" as indicated above covered by Annual Budget for CY 2015.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Four Million Five Hundred Sixty Nine Thousand Six Hundred Pesos (PhP4,569,600.00) for the "Office Supplies Expenses" and the "Other Supplies (Printing) Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2015;

Section 2. The above-mentioned amount of Four Million Five Hundred Sixty Nine Thousand Six Hundred Pesos (PhP4,569,600.00) shall be re-aligned from the "Other Maintenance and Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2015;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.
