AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAYS DIGMAN AND P.F. ESPIRITU VIII IN THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of the following barangays to wit:

1. Digman – Two Hundred Fifty Thousand Eight Hundred Thirty Nine Pesos and 42/100 (Php 250,839.42) (Please see attached Barangay Resolution No. 02-2015 and Appropriation Ordinance No. 02-2015 Series of 2015 dated June 30, 2015);
2. P.F. Espiritu VIII – Five Hundred Forty Eight Thousand Four Hundred Ninety Pesos and 85/100 (Php548,490.85) (Please see attached Barangay Resolution No. 02-2015 and Appropriation Ordinance No. 02-2015 Series of 2015 dated May 2, 2015);

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its 88th regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Digman and P.F. Espiritu VIII provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.
