**WHEREFORE**, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Molino VI, Molino III, Real II, Zapote IV, Daang Bukid, Niog I, Ligas II and Maliksi III provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
