**AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND  
BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual General Fund Budget of Barangays to wit:

1. Molino VII – Six Million Four Hundred Eighty Four Thousand Four Hundred Sixty Pesos (Php6,484,460.00) (Please see attached Barangay Resolution No. 01-2015 Series of 2015 and Appropriation Ordinance No. 1 dated January 2, 2015);
2. San Nicolas II – Five Million Eight Hundred Thirty Two Thousand Nine Hundred Fifty Eight Pesos (Php5,832,958.00) (Please see attached Barangay Resolution No. 01-15 Series of 2015 and Appropriation Ordinance No. 1 dated January 5, 2015);
3. Queens Row East - Eight Million Five Hundred Ninety Three Thousand Twenty Six Pesos (Php8,593,026.00) (Please see attached Barangay Resolution No. 01-15 Series of 2015 and Appropriation Ordinance No. 1 dated January 10, 2015);
4. Salinas I – Seven Million Three Hundred Forty Seven Thousand Seven Hundred Eighty Eight Pesos (Php7,347,788.00) (Please see attached Appropriation Ordinance No. 06 Series of 2014 dated October 20, 2014);
5. P. F. Espiritu II – Two Million Three Hundred Fifty Two Thousand Nine Hundred Fifty Eight Pesos ( Php 2,352,958.00) ( Please see attached Barangay Resolution No. 01-15 Series of 2015 dated January 9, 2015 and Appropriation Ordinance No. 01-2015 dated January 5, 2015); and

6. Talaba VI – Two Million Two Hundred Fifty Two Thousand One Pesos (Php2,252,001.00) (Please see attached Barangay Resolution No. 01-15 Series of 2015 and Appropriation Ordinance 1 dated January 2, 2015);

**WHEREAS**, the City Budget Officer, Mrs. Elvinia Guerrero, reported to the Sangguniang Panlungsod that the item for disbursement of appropriation in the proposed budget of the above mentioned various Barangays for Ugnayan ng Barangay at Simbahan (UBAS) should be held in abeyance pending submission by the said barangays of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes".

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays Molino VII, San Nicolas II, Queens Row East, Salinas I, P. F. Espiritu II and Talaba VI provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED MOREOVER**, the item for disbursement of appropriation in the proposed budget of the said various Barangays for Ugnayan ng Barangay at Simbahan (UBAS) shall be held in abeyance pending submission by the said barangays of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes" to wit:

- a. Barangay Molino VII - Php 58,844.60;
- b. Barangay San Nicolas II - Php 53,479.58;
- c. Barangay Queens Row East - Php 72,730.26;
- d. Barangay Salinas I – Php 69,007.88;
- e. Barangay P. F. Espiritu II – Php 19,579.58; and
- f. Barangay Talaba VI – Php 21,520.01

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangay Molino VII, San Nicolas II, Queens Row East, Salinas I, P.F. Espiritu II, Talaba VI and others concerned for their information and guidance.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
