AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF THE CITY OF BACOOR, PROVINCE OF CAVITE FOR FISCAL YEAR 2016 IN THE TOTAL AMOUNT OF ONE BILLION SIX HUNDRED SIX MILLION TWO HUNDRED NINETY SEVEN THOUSAND NINE HUNDRED FORTY NINE PESOS (PHP1,606,297,949.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE BACOOR CITY GOVERNMENT FOR CALENDAR YEAR 2016, AND APPROPRIATING THE NECESSARY FUNDS FOR THE SAID PURPOSE.

Be it ordained by the Sangguniang Panlungsod in Regular Session assembled:

Section 1. The Annual Budget of the City of Bacoor, Province of Cavite for Calendar Year 2016 in the total amount of One Billion Six Hundred Six Million Two Hundred Ninety Seven Thousand Nine Hundred Forty Nine Pesos (PhP 1,606,297,949.00) covering the various expenditures for the operation of the Bacoor City Government for the year 2016 is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral parts of this Ordinance:

1. Budget of Expenditures and Sources of Financing;
2. Annual Investment Program; and
3. Local Expenditure Program.

Section 2. Sources of Funds.

The sources of funds for the annual budget for the year 2016 can be found in Part I – Table I (Receipts Program) of the Local Expenditure Program.

Section 3. Use of Funds.

The various purposes for which the funds covered by the annual budget of the City Government of Bacoor shall be used has been enumerated in Part II – Expenditure Program of Local Expenditure Program and made an integral part hereof.

In addition to this, the following positions and the Bacoor Disaster Risk Reduction and Management Department which salaries have been appropriated herein are hereby created, to wit:

Section 5. Use of Savings and Augmentation. "Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

Section 6. Priority in the Use of Personal Services Savings. Priority shall be given to the personnel benefits of local employees in the use of Personal Services savings.

Section 7. Separability Clause. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed during Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 8. Effectivity. The provisions of this Appropriation Ordinance shall take effect on 01 January 2016.
