**AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.**

2. Salinas II – Six Hundred Nine Thousand Eight Hundred Seventy Three Pesos and 54/100 (Php 609,873.54) (Please see attached Barangay Resolution No. 01-2016 and Barangay General Appropriation Ordinance No. 01-2016 Series of 2016 dated June 15, 2016);

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Real I and Salinas II, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.




