AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY
BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.

WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

3. Panapaan IV – Four Hundred Eighteen Thousand Two Hundred Fifty Pesos (Php 418,250.00) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated September 19, 2016);
4. Habay I – Four Hundred Thousand Pesos (Php 400,000.00) (Please see attached Barangay Resolution No. 09-2016 Series of 2016 and Barangay Appropriation Ordinance No. 03-2016 Series of 2016 dated September 19, 2016);
