AN ORDINANCE APPROVING THE SUPPLEMENTAL
BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF
BACOR.

WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Zapote IV – Two Hundred Eighty Seven Thousand Seven Hundred Twenty Eight Pesos and 33/100 (Php 287,728.33) (Please see attached Barangay Resolution No. 03-2016 and Barangay Appropriations Ordinance No. 03-2016 Series of 2016 dated October 3, 2016); and
2. Queens Row West – One Hundred Ninety Four Thousand One Hundred Seven Pesos and 33/100 (Php 194,107.33) (Please see attached Barangay Resolution No. 003-2016 Series of 2016 and Appropriation Ordinance No. 0010-001-2016 Series of 2016 dated October 3, 2016).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Zapote IV and Queens Row West, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.






