AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE HUNDRED EIGHTY EIGHT THOUSAND PESOS (PHP 188,000.00) FROM THE "TRAVELLING EXPENSES - LOCAL" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "TRAVELLING EXPENSES-FOREIGN" UNDER THE BUDGET OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD AND REALIGNING THE AMOUNT OF ONE HUNDRED SIXTY TWO THOUSAND PESOS (PHP162,000.00) FROM THE "TRAVELLING EXPENSES - LOCAL" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "TRAVELLING EXPENSES-FOREIGN" UNDER THE BUDGET OF THE OFFICE OF THE HUMAN RESOURCES DEVELOPMENT AND MANAGEMENT DEPARTMENT (HRDMD), CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2016.

WHEREAS, submitted for review and approval are the proposed re-alignment of funds under the "Travelling Expenses-Local" to "Travelling Expenses-Foreign" under the budget of the Office of the Sangguniang Panlungsod and the Office of the Human Resources Development and Management Department (HRDMD) covered by the Annual General Fund Budget for Calendar Year 2016 by the Office of the City Mayor;

WHEREAS, selected city officials of the City Government of Bacoor will travel to the City of Guangzhou, People's Republic of China for the purpose of creating harmonious partnership in the areas of education, health services, tourism and information technology on November 22 - 25, 2016, through the signing of a Sister Cities Agreement.

WHEREAS, the funds of the Sangguniang Panlungsod for calendar year 2016, is bereft of appropriations for foreign travel. Hence, there is a need for the re-alignment of funds in the budget of the Sangguniang Panlungsod and the Human Resources Development Management Department (HRDMD) intended for local travel.

WHEREAS, the funds to be re-aligned shall no longer be used by the Office of the Sangguniang Panlungsod and Human Resources Development and Management Department (HRDMD) for the "Traveling Expenses - Local" considering that there are sufficient available funds to finance the traveling expenses for local travel of the said offices;
