7. Salinas I - Seven Hundred Thousand Pesos ( Php 700,000.00)  
(Please see attached Barangay Resolution No. 14-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 06-2016 Series of 2016 dated October 20, 2016;
