AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY
BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

4. **Banalo** – Thirty Two Thousand Four Hundred Fifteen Pesos and 08/100 (Php 32,415.08) (Please see attached Barangay Resolution No. 04-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 03-2016 Series of 2016 dated October 08, 2016);
5. **Ligas I** – One Hundred Thirty Eight Thousand Three Hundred Fifty Three Pesos and 42/100 (Php138,353.42) (Please see attached Barangay Resolution No. 03-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 03 Series of 2016 dated November 15, 2016.


ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.
