AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY
BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. **Ligas II** – Three Hundred Eighty Six Thousand Eight Hundred Fifty Three Pesos and 83/100 (Php 386,853.83) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay Appropriation Ordinance No. 02-2016 Series of 2016 dated November 4, 2016);
2. **Niog III** – One Hundred Ninety Nine Thousand Ninety Pesos and 47/100 (Php 199,090.47) (Please see attached Barangay Resolution No. 03-2016 Series of 2016 and Barangay Appropriation Ordinance No. 04-2016 Series of 2016 dated November 15, 2016);
3. **Daang Bukid** – Ninety Eight Thousand Three Hundred Eighty Five Pesos and 57/100 (Php 98,385.57) (Please see attached Barangay Resolution No. 03-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 03-2016 Series of 2016 dated December 01, 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Ligas II, Niog III, Daang Bukid provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.
