AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF BARANGAY BAYANAN AND THE AMENDED ANNUAL GENERAL FUND BUDGET OF BARANGAY SAN NICOLAS II FOR FISCAL YEAR 2017 IN THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual General Fund Budget of various Barangays to wit:

1. Bayanan – Six Million Eight Hundred Seventy Five Thousand Seven Hundred Seventy Five Pesos (Php 6,875,775.00) (Please see attached Barangay Resolution No. 04-16 and Barangay General Appropriation Ordinance No. 04-16 dated December 12, 2016);
2. San Nicolas II – Seven Million Three Hundred Eighty One Thousand Nine Hundred Fifty Nine Pesos (Php 7,381,959.00) (Please see attached Barangay Resolution No. 04-16 and Barangay General Appropriation Ordinance No. 04-2016 dated November 18, 2016);

WHEREAS, the Annual General Fund Budget of Barangay San Nicolas II for FY 2017, was originally approved on 16 January 2017 by the Sangguniang Panlungsod. Subsequently, however, it was discovered by the city council that the said budget exceeded the 55% cap for personal services under Section 331(b) of Republic Act No. 7160. Consequently, the Body recommended to Barangay San Nicolas II to amend its proposed budget for FY 2017 for it to comply with the said provision of law.

WHEREAS, Barangay San Nicolas II submitted its amended Annual General Fund Budget for FY 2017 on 27 January 2017 together with the favorable endorsement of City Budget Office in conformity with Section 331(b) of RA 7160.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to (a) **APPROVE** the Annual General Fund Budget of Barangay Bayanan for FY 2017 amounting to Six Million Eight Hundred Seventy Five Thousand Seven Hundred Seventy Five Pesos (Php 6,875,775.00); (b) **REVOKE** the portion of City Ordinance No. CO 4-2017 dated 16 January 2017 with regard the proposed Annual General Fund Budget of Barangay San Nicolas II for FY 2017; and (c) **APPROVE** the amended Annual General Fund Budget of Barangay San Nicolas II for FY 2017 amounting to Seven Million Three Hundred Eighty One Thousand Nine Hundred Fifty Nine Pesos (Php 7,381,959.00).

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Bayanan and San Nicolas II and other government offices concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.

APPROVED UNANIMOUSLY, this 6th day of February 2017 by the Sangguniang Panlungsod of Bacoor.
