AN ORDINANCE AMENDING SECTION 85 OF THE CITY
ORDINANCE NO. 2013-047.

WHEREAS, a recommendation letter was sent by the Office of the City Bacoor Traffic Management headed by Mr. Geronimo Del Rosario requesting the Sangguniang Panlungsod to include the Mambog Road among the public roads covered by the truck ban under Section 85 of City Ordinance No. 2013-047 enacted on 7 October 2013 entitled: "**AN ORDINANCE AMENDING CITY ORDINANCE NO. 2013-2, SERIES OF 2013, OTHERWISE KNOWN AS THE REVISED TRAFFIC CODE OF THE CITY OF BACOR**".

WHEREAS, the said request was referred to the Committee on Public Transportation and Traffic Management headed by Councilor Apolonio Advincula, Jr. for further study and evaluation;

WHEREAS, a Committee Report was submitted to the council recommending that the request of the City Bacoor Traffic Management Office be approved.

NOW, THEREFORE:

Be it ordained by the Sangguniang Panlungsod of Bacoor, Cavite in regular session assembled that:

Section 1. Section 85, of City Ordinance No. 2013-047 is hereby amended to read as follows:

"Section 85. Truck Ban. xxx

No cargo trucks shall be allowed to travel or pass along Mambog Road, and Zapote-Salawag Road from the junction of Daang Hari to Zapote, Bacoor, Cavite everyday.

Section 2. Separability Clause.--Any judicial declaration invalidating any provision of this Ordinance shall not affect the other provisions hereof not affected by such declaration.

Section 3. Effectivity. --This Ordinance shall take effect within fifteen (15) days after it has been published at least once in a newspaper of general circulation in the Province of Cavite and after it has been posted in at least two (2) conspicuous places within the City of Bacoor, Cavite.

Section 4. Repealing Clause. - Any ordinance in conflict with this Ordinance is hereby repealed and/or modified accordingly.
