2. Talaba VI – One Hundred Sixty Two Thousand Six Hundred Twenty Four Pesos and 38/100 (Php 162,624.38) (Please see attached Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated January 15,2017);
3. Mambog III – Eight Hundred Thirty Seven Thousand Six Hundred Fifty Six Pesos and 71/100 (Php 837,656.71) (Please see attached Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated January 31,2017);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Salinas II, Talaba VI and Mambog III, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
