AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO II AMOUNTING TO FIVE MILLION NINETY NINE THOUSAND THREE HUNDRED NINETY PESOS (Php 5,099,390.00).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of barangay Molino II in the amount of Five Million Ninety Nine Thousand Three Hundred Ninety Pesos (Php 5,099,390.00).
