AN ORDINANCE AMENDING CERTAIN PROVISIONS OF CITY ORDINANCE NO. CO 7-2017 OTHERWISE KNOWN AS "A CITY ORDINANCE PURSUING A PUBLIC-PRIVATE PARTNERSHIP (PPP) APPROACH TOWARDS DEVELOPMENT, PROVIDING FOR THE PROCEDURE FOR SELECTING THE PRIVATE SECTOR PROPONENT, ADOPTING MANAGEMENT FRAMEWORK, PROVIDING APPROPRIATIONS AND INCENTIVES THEREFOR AND FOR OTHER PURPOSES AND KNOWN AS THE PPP CODE OF BACoor".

**WHEREAS**, the Sangguniang Panlungsod unanimously approved City Ordinance No. CO7-2017 otherwise known as: "A CITY ORDINANCE PURSUING A PUBLIC-PRIVATE PARTNERSHIP (PPP) APPROACH TOWARDS DEVELOPMENT, PROVIDING FOR THE PROCEDURE FOR SELECTING THE PRIVATE SECTOR PROPONENT, ADOPTING MANAGEMENT FRAMEWORK, PROVIDING APPROPRIATIONS AND INCENTIVES THEREFOR AND FOR OTHER PURPOSES AND KNOWN AS THE PPP CODE OF BACoor" on 30 January 2017.

**WHEREAS**, the Sangguniang Panlalawigan returned the said ordinance to the Sangguniang Panlungsod on 15 March 2017 with the directive that certain provisions thereof should be amended.

**WHEREAS**, in compliance with the said directive, the members of the Sangguniang Panlungsod unanimously decided to amend certain provisions of City Ordinance No. CO 7-2017.

Article I  
Preliminary Provisions

**Section 1.** Section 10(e) of City Ordinance No. CO 7-2017 otherwise known as the "PPP Code of Bacoor" is hereby amended and shall henceforth read as follows:

**"(e) To exercise such other powers and functions as may be authorized by the Sangguniang Panlungsod."**

**Section 2.** Section 23(h) of City Ordinance No. CO 7-2017 is hereby amended and shall henceforth read as follows:

**"(h) All PPP contracts must be signed by the City Mayor with prior authorization by the Sangguniang Panlungsod. After careful consideration of any PPP Contract endorsed to the Sangguniang Panlungsod for approval in accordance with the succeeding subparagraph, the Sangguniang Panlungsod shall authorize the City Mayor through a resolution duly passed to sign the PPP Contract. The resolution approving the PPP Contract shall then be transmitted by the Sangguniang Panlungsod to the Sangguniang Panlalawigan pursuant to the applicable provisions of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991".**

**Section 3.** This Ordinance shall take effect immediately after it has been published at least once in a newspaper of general circulation in the Province of Cavite and after it has been approved by the Sangguniang Panlalawigan of the Province of Cavite.

**Section 4.** The Sangguniang Panlungsod shall automatically review this Ordinance and City Ordinance No. CO 7-2017 once every three (3) years after its approval or whenever the need for such review arises.


**Section 5.** All ordinances, resolutions, or executive orders in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

**Section 6.** Any provision of this Ordinance nullified by any court of law shall not affect the validity of the remaining provisions hereof that are not affected by the said judicial declaration.




