AN ORDINANCE NAMING THE NEW CITY HEALTH STATIONS IN BARANGAY QUEENSROW, SALINAS, ANIBAN AND MOLINO IV AS "CITY OF BACOOOR HEALTH UNITS" IN THE CITY OF BACOOOR, CAVITE.

**WHEREAS**, the Office of the City Administrator, requested the Sangguniang Panlungsod to pass an ordinance naming the new city health stations in barangays Queensrow, Salinas, Aniban and Molino IV as "City of Bacoor Health Units;

**WHEREAS**, the said matter was referred to the Committee on Health and Sanitation headed by its Chairman Hon. Roberto Javier for further study;

**WHEREAS**, the said committee conducted a series of hearings and submitted a committee report recommending the approval of the said request;

**NOW THEREFORE**, upon motion of Councilor Roberto R. Javier, unanimously approved by all the councillors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled that:

**Section 1. Title.**—This Ordinance shall also be known as the "Naming of New City of Bacoor Health Unit Ordinance".

**Section 2. Naming of the New City Health Stations in Barangays Queenrow, Salinas, Aniban and Molino IV** –These health stations are hereby named as:

- CITY OF BACOOOR HEALTH UNIT - QUEENROW CENTRAL
- CITY OF BACOOOR HEALTH UNIT - SALINAS 2
- CITY OF BACOOOR HEALTH UNIT – ANIBAN 3
- CITY OF BACOOOR HEALTH UNIT – MOLINO 4

**Section 3. Separability Clause.** – If, for any reason or reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not

**Section 4. Repealing Clause.** – All Ordinances, resolutions, Circulars, Memorandums or Rules and regulations inconsistent with the provision of this Ordinance are hereby repealed and modified accordingly.

**Section 5. Effectivity Clause.** – This Ordinance shall take effect immediately upon its posting in at least three (3) conspicuous places within the City of Bacoor, and after it has been approved by the Office of the Sangguniang Panlalawigan;

**Section 6. Dissemination.** Let copies of this Ordinance be furnished to the Office of the City Mayor, to the City Health Office, the Department of Health and to other government offices concerned.
