**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO VI AMOUNTING TO SIX HUNDRED SEVENTY EIGHT THOUSAND FIFTY SIX PESOS AND 30/100 (Php 678,056.30).**
