AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY SALINAS II AMOUNTING TO EIGHT HUNDRED THIRTEEN THOUSAND NINE HUNDRED EIGHTY PESOS (PHP 813,980.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Salinas II in the amount of Eight Hundred Thirteen Thousand Nine Hundred Eighty Pesos (Php 813,980.00). Attached is the Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated May 8, 2017.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Salinas II provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
