**AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.**

**WHEREAS**, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

3. Salinas IV – Five Hundred Seventy Two Thousand One Hundred Ninety Seven Pesos and 18/100 (Php 572,197.18) (Please see attached Barangay Resolution No. 03-2017 Series of 2017 and Appropriation Ordinance No. 03-2017 Series of 2017 dated March 1, 2017)
