AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACCOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

3. Mambog III - One Million Four Hundred Thirty Five Thousand Seven Hundred Twenty Two Pesos (Php 1,435,722.00) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated August 03, 2017), and
4. Mambog V - Three Hundred Eighty Eight Thousand One Hundred Ninety Six Pesos and 75/100 (Php 388,196.75) (Please see attached Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated June 26, 2017).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Habay I, Digman, Mambog III & Mambog V, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
