CITY ORDINANCE NO. CO 41-2017

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY SAN NICOLAS II AMOUNTING TO ONE MILLION FOUR HUNDRED THREE THOUSAND FOUR HUNDRED NINETY THREE PESOS AND 76/100 (PHP 1,403,493.76) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay San Nicolas II in the amount of **One Million Four Hundred Three Thousand Four Hundred Ninety Three Pesos And 76/100 (Php 1,403,493.76)**. Attached is the Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated June 23, 2017.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay San Nicolas II provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
