AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Banalo – Eighty Seven Thousand Five Hundred Eighty Seven Pesos and 07/100 (Php 87,587.07) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated July 14,2017), and
2. Talaba VI – One Hundred Twenty Seven Thousand Six Hundred Forty Two Pesos and 03/100 (Php 127,642.03) (Please see attached Barangay Resolution No. 03-2017 Series of 2017 and Appropriation Ordinance No. 03-2017 Series of 2017 dated July 11,2017)

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Banalo and Talaba VI, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
