**AN ORDINANCE REVERTING THE AMOUNT OF FOUR MILLION PESOS (PHP 4,000,000.00) FROM THE "FUEL, OIL, AND LUBRICANTS EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "WATER EXPENSES" UNDER THE BUDGET OF THE GENERAL SERVICES OFFICE, CITY GOVERNMENT OF BACoor, CAVITE FOR CALENDAR YEAR 2017.**

**Section 1.** The purpose of this Ordinance is to appropriate the amount of Four Million Pesos (PhP4,000,000.00) for the "Water Expenses" under the budget of the Office of the General Services for Calendar Year 2017;

**Section 2.** The above-mentioned amount of Four Million Pesos (PhP4,000,000.00) shall be reverted from the "Fuel, Oil & Lubricants Expenses" under the budget of the Office of the General Services for Calendar Year 2017;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** —This Appropriation Ordinance shall take effect upon its approval.
