AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY ZAPOTE III AMOUNTING TO FIVE HUNDRED SEVEN THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND 69/100 (PHP 507,452.69).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Zapote III in the amount of Five Hundred Seven Thousand Four Hundred Fifty Two Pesos and 69/100 (Php 507,452.69). Attached is the Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated September 11, 2017.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Zapote III provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
