









AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MAMBOG I AMOUNTING TO TWO MILLION EIGHT HUNDRED THIRTY THOUSAND PESOS (PHP 2,830,000.00) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Mambog I in the amount of **Two Million Eight Hundred Thirty Thousand Pesos (Php 2,830,000.00)**. Attached is the Barangay Resolution No. 2017-015 and Appropriation Ordinance No. 02-2017 dated August 22, 2017.
