**APPROPRIATION ORDINANCE NO. CO 49-2017  
SERIES OF 2017**

**AN ORDINANCE RE-ALIGNING THE AMOUNT OF THIRTY ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 31,500,000.00) ALLOCATED FROM THE 20% CITY DEVELOPMENT FUND BY THE MEMBERS OF THE CITY DEVELOPMENT COUNCIL FOR THE CALENDAR YEAR 2017.**

**WHEREAS**, the proposed re-alignment of funds amounting to Thirty One Million Five Hundred Thousand Pesos (Php31,500,000.00) allocated from the 20% City Development Fund by the Members of the City Development Council (CDC) for Calendar Year 2017 as enumerated in CDC Resolution No. 03 (Series of 2017) was submitted for review and approval of the Sangguniang Panlungsod.

**WHEREAS**, CDC Resolution No. 03 (Series of 2017) provides that the following approved priority development projects for 2017 were not implemented due to various problems related to their implementation, to wit:
