**AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (PHP 1,200,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD TO THE PAYMENT OF EXPENSES TO BE INCURRED FOR TRAINING EXPENSES AND REPAIR/MAINTENANCE OF VEHICLES.**

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of One Million Two Hundred Thousand Pesos (PhP 1,200,000.00) for the payment of expenses to be incurred for training expenses and repair/maintenance of vehicles.

**Section 2.** The above-mentioned amount of One Million Two Hundred Thousand Pesos (PhP 1,200,000.00) shall be realigned from the "Other Maintenance & Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2017;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** —This Appropriation Ordinance shall take effect upon its approval.
