AN ORDINANCE REQUIRING THE SINGING OF THE "HIMNO NG BACOR" IN ALL CINEMAS, SCHOOLS, AND UNIVERSITIES OPERATING WITHIN THE CITY OF BACOR TOGETHER WITH THE PHILIPPINE NATIONAL ANTHEM AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

BE IT ORDAINED by the Sangguniang Panlungsod in regular session duly assembled THAT:

Section 1. Title. This Ordinance shall be known as the "**Himno ng Bacoor Ordinance of the City of Bacoor**".

Section 2. Mandatory Singing. The singing and playing of the "Himno ng Bacoor" shall be strictly observed in all cinemas, theaters, reputable places of entertainment, schools, universities, and government offices operating within the City of Bacoor right after the playing and singing of the Philippine National Anthem.

Section 3. Manner of Singing. All persons present in the places above-mentioned shall sing the "Himno ng Bacoor" solemnly while standing in attention with both arms on the side of the body. The refusal of any person in the said places to sing the "Himno ng Bacoor" in the manner mentioned above with no justifiable reason, or the ridiculing of the said song by changing its lyrics, or by doing anything that lessens the dignity required to be accorded to either the Philippine National Anthem or the "Himno ng Bacoor", shall be deemed a violation of this ordinance.

Section 4. Official Lyrics of the Himno ng Bacoor. To ensure uniformity, the managers, owners, administrators, principals, supervisors, or any other person in authority in the places mentioned in Section 2 hereof are hereby required to display the official lyrics of the "Himno ng Bacoor" while it is being sung.





Section 5. Production and Distribution of the Audio-Visual Presentation (AVP) of the "Himno ng Bacoor".

To ensure compliance to this ordinance, the City Government of Bacoor shall produce and distribute an official audio-visual presentation (AVP) of the "Himno ng Bacoor" in order to highlight and emphasize the cultural heritage of the City of Bacoor and in the process develop the sense of belongingness of the population, inculcate pride of being a Bacooreño and showcase the beauty and uniqueness of Bacoor as a tourist destination. The AVP shall include, but not be limited to, the tourist destinations, places with historical importance within the city, the role of the youth, and the legacy of the political and lay

leaders of the city. The produced AVP shall be subject to the approval of existing video regulatory standards for public viewing.

Section 6. Playing of the Audio-Video Presentation (AVP) in Cinemas and Theaters. The owners, operators and managers of various cinemas and theaters in the city are hereby enjoined to play the AVP before their first and last screening following the Philippine National Anthem.

Section 7. Playing of the Audio-Video Presentation (AVP) in Public and Private Schools, and universities. School and university administrators, principals, supervisors and other authorities shall instruct the playing of the AVP of the "Himno ng Bacoor" during their flag-raising ceremonies, recognition and commencement ceremonies, sporting events, academic competitions and before any official event that are being conducted in their respective schools and universities.

Section 8. Appropriation of Funds. For the purpose of production and distribution of the audio-visual presentation (AVP) of the "Himno ng Bacoor", which will not be more than five (5) minutes but not less than three (3) minutes in length, the City Government shall allocate from the General Fund the amount of Five Hundred Thousand Pesos (P 500,000.00) subject to prevailing accounting rules and regulations.

Section 9. Penalties. Violations and non-compliance to this ordinance shall have the following penalties:

a) Any person found defaming or disrespecting the "Himno ng Bacoor" or the Philippine National Anthem as prescribed in Section 3 of this ordinance shall be penalized with a fine of not more than One Thousand Pesos (P 1,000.00) or render two (2) hours of community service.

b) Any owner, manager or supervisory personnel of any cinema and theater operating within the city who violates the provisions hereof shall be penalized with a fine of Five Thousand Pesos (P 5,000.00).

c) Any private school and university person-in-authority shall be meted a fine of Two Thousand Pesos (P 2,000.00) for non-compliance to this ordinance.

d) Any public school and university person-in-authority shall be meted with the appropriate administrative disciplinary action for non-compliance to this ordinance.

Section 10. Separability Clause. Should any provision of this Ordinance be declared unconstitutional or invalid by any Court of competent jurisdiction, other parts or provisions hereof which are not affected thereby shall remain valid and binding.





Section 11. Repeal Clause. All Ordinances, resolutions, executive orders, memoranda, or circular not consistent with the provisions of this Ordinance are hereby repealed, modified, or amended.

Section 12. Effectivity Clause. This Ordinance shall become effective fifteen (15) days after it has been published at least once in a newspaper of general circulation, posted on at least three (3) conspicuous places within the City of Bacoor, and after it has been approved by the Sangguniang Panlalawigan of the Province of Cavite.
