**AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Ligas II – Four Hundred Six Thousand Seven Hundred Fourteen Pesos (Php 406,714.00) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated September 5, 2017), and
2. Panapaan III – Three Hundred Seventy Three Thousand Seven Hundred Seventy Seven Pesos and 86/100 (Php 373,777.86) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated October 15, 2017)

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Ligas II and Panapaan III, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
