AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY HABAY I AMOUNTING TO NINE HUNDRED FIFTY THOUSAND PESOS (PHP 950,000.00) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Habay I in the amount of Nine Hundred Fifty Thousand Pesos (Php 950,000.00).
