**AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. **Mambog I** – Six Hundred Twenty Eight Thousand Pesos (Php 628,000.00) (Please see attached Barangay Resolution No. 2016-011 and Barangay Appropriation Ordinance No. 02-2016 dated October 24, 2016);
2. **Habay I** – One Hundred Fifty Five Thousand Pesos (Php 155,000.00) (Please see attached Barangay Resolution No. 10-2016 and Barangay Appropriation Ordinance No. 04-2016 dated October 28, 2016);
3. **Mambog V** – One Hundred Sixty Five Thousand Seven Hundred Seventy Nine Pesos and 06/100 (Php 165,779.06) (Please see attached Barangay Resolution No. 01-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 01-2016 Series of 2016 dated October 10, 2016; and
4. **Salinas III** – Sixty Five Thousand Seven Hundred Seventeen Pesos and 79/100 (Php 65,717.79) (Please see attached Barangay Resolution No. 03-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 03 Series of 2016 dated November 4, 2016.

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Mambog I, Habay I, Mambog V and Salinas III provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
