AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Aniban II – Three Hundred Fifty Seven Thousand One Hundred Seventeen Pesos and 40/100 (Php 357,117.40) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated November 2, 2017) and;
2. Queens Row West – Ninety Seven Thousand Fifty Five Pesos and 03/100 (Php 97,055.03) (Please see attached Barangay Resolution No. S-010-002-2017 Series of 2017 and Appropriation Ordinance No. 2017-010-003 Series of 2017 dated October 16, 2017);
3. Molino IV – Thirteen Million Three Hundred Forty Two Thousand Ninety Seven Pesos and 51/100 (Php 13,342,097.51) (Please see attached Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated September 25, 2017) and;
4. Molino VII – Nine Hundred Twenty Eight Thousand One Hundred Forty Four Pesos and 91/100 (Php 928,144.91) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated October 16, 2017).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Aniban II, Queens Row West, Molino IV and Molino VII, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
