**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4 SERIES OF 2017 INVOLVING THE AMOUNT OF ELEVEN MILLION TWO HUNDRED TEN THOUSAND PESOS (PHP 11,210,000.00) FOR CURRENT OPERATING EXPENDITURES OF THE CITY GOVERNMENT OF BACOR FOR FISCAL YEAR 2017.**

Be it ordained in regular session assembled that:

**Section 1.** The Supplemental Budget of the City Government of Bacoor for the Fiscal Year 2017 in the amount of **Eleven Million Two Hundred Ten Thousand Pesos (PHP 11,210,000.00)** for operating expenditures is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral parts of this Ordinance:

1. Statement of Supplemental Appropriations; and
2. Statement of Funding Sources.
