AN ORDINANCE AMENDING SECTION 35, PARAGRAPH A AND SECTION 40 OF THE CITY ORDINANCE NO. 2013-047.

Sponsored by: Coun Apolonio I. Advincula, Jr., Coun. Miguel N. Bautista, Coun. Venus D. De Castro, Coun. Leandro A. De Leon, Coun. Edwin G. Gawaran, Coun. Victorio L. Guerrero, Jr., Coun. Hernando C. Gutierrez, Coun. Alejandro F. Gutierrez, Coun. Roberto R. Javier, Coun. Gaudencio P. Nolasco, and Coun. Reynaldo D. Palabrica.

WHEREAS, a board resolution was sent by the Office of Bacoor City Transportation and Franchising Board requesting the Sangguniang Panlungsod for an amendment to Section 35, Paragraph A, and Section 40 of the City Ordinance No. 2013-047 enacted on 7 October 2013 entitled: "**AN ORDINANCE AMENDING CITY ORDINANCE NO. 2013-2, SERIES OF 2013, OTHERWISE KNOWN AS THE REVISED TRAFFIC CODE OF THE CITY OF BACOOOR**".

WHEREAS, the said request was referred to the Committee on Government Enterprises and Privatization and Public Franchises headed by Councilor Edwin G. Gawaran for further study and evaluation;

WHEREAS, Committee Report was submitted to the council recommending that the request of the Bacoor City Transportation and Franchising Board be approved.

NOW, THEREFORE:

Be it ordained by the Sangguniang Panlungsod of Bacoor, Cavite in regular session assembled that:

Section 1. Section 35, Paragraph A, and Section 40 of City Ordinance No. 2013-047 is hereby amended to read as follows:

"Section 35. Terms and Conditions of the Franchise.

a. **The Motorized Tricycle Operator's Permit for motorized tricycles and E-trike for hire and Operator's Permit for Pedicabs shall be valid for one (1) year from the date of issuance.**

Section 40. The Operator's Permit for motorized tricycles and E-Trike for hire and Pedicabs . -All fees being currently charged by the City Government of Bacoor for the grant of new permits or for the renewal of existing permits for conventional PUVs shall be maintained, until further notice and revision by the BCTFB, to wit:

| Renewal Fee (every year) | 350.00 |
| Dropping Fee | 200.00 |
| Change of Motor | 200.00 |

Section 2. Separability Clause.--Any judicial declaration invalidating any provision of this Ordinance shall not affect the other provisions hereof not affected by such declaration.

Section 3. Effectivity. --This Ordinance shall take effect within fifteen (15) days after it has been posted in at least two (2) conspicuous places within the City of Bacoor, Cavite.

Section 4. Repealing Clause. - Any ordinance in conflict with this Ordinance is hereby repealed and/or modified accordingly.
