AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY CAMPOSANTO AMOUNTING TO FIFTY SIX THOUSAND FOUR HUNDRED FORTY TWO PESOS AND 86/100 (PHP 56,442.86) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Camposanto in the amount of **Fifty Six Thousand Four Hundred Forty Two Pesos And 86/100 (Php 56,442.86)**.
