**AN ORDINANCE REALIGNING THE AMOUNT OF FOUR MILLION SIX HUNDRED THOUSAND (PHP 4,600,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD TO THE PAYMENT OF EXPENSES TO BE INCURRED FOR "ADVERTISING EXPENSES, TRAINING EXPENSES, AND REPAIR AND MAINTENANCE OF MOTOR VEHICLES".**

**NOW THEREFORE**, upon unanimous motion of all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds under the budget of the Office of the Sangguniang Panlungsod from the "Other Maintenance & Operating Expenses" to the payment of expenses to be incurred for "Advertising Expenses, Training/Workshop/Seminars, and Repair and Maintenance of Motor Vehicles".

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of Four Million Six Hundred Thousand Pesos (PhP4,600,000.00) for the payment of expenses to be incurred for advertising expenses, training/workshop seminar, and repair and maintenance of motor vehicles.

**Section 2.** The above-mentioned amount of Four Million Six Hundred Thousand Pesos (PhP4,600,000.00) shall be realigned from the "Other Maintenance & Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2018;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** —This Appropriation Ordinance shall take effect upon its approval.
