





CITY ORDINANCE NO. CO 16-2018

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY QUEENS ROW WEST AMOUNTING TO ONE MILLION ONE HUNDRED FIFTY THOUSAND PESOS (PHP 1,150,000.00) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Queens Row West in the amount of **One Million One Hundred Fifty Thousand Pesos (Php 1,150,000.00)**. Attached is the Barangay Resolution No. S-005-001-2018 Series of 2018 and Appropriation Ordinance No. 2018-005-001 Series of 2018 dated April 16, 2018.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Queens Row West provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
