





AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

2. Panapaan VII – Seventy Nine Thousand One Hundred Twenty Four Pesos and 69/100 (Php 79,124.69) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated May 25, 2018);
3. San Nicolas I – Three Hundred Six Thousand One Hundred Seventy Seven Pesos and 55/100 (Php 306,177.55) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated May 26, 2018);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of the following Barangays Niog I, Panapaan VII and San Nicolas I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
