**APPROPRIATION ORDINANCE NO. CO 24-2018**

**AN ORDINANCE REVERTING THE AMOUNT OF SIX MILLION PESOS (PHP 6,000,000.00) FROM THE "OTHER PROFESSIONAL SERVICES (CONCEPTUAL DEVELOPMENT PLANNING-CDP)" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OTHER PROFESSIONAL SERVICES (COMPREHENSIVE LAND USE PLAN - CLUP)" UNDER THE BUDGET OF THE OFFICE OF THE CITY MAYOR (VARIOUS LOCAL GOVERNMENT AFFAIRS), CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2018.**

Rowena Bautista-Mendiola seconded by all the councilors present in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the reversion of funds under the budget of the City Mayor's Office (Various Local Government Affairs) from the "Other Professional Services (Conceptual Development Planning-CDP)" to "Other Professional Services (Comprehensive Land Use Plan - CLUP)" as indicated above covered by Annual General Fund Budget for CY 2018.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that:

Section 1. The purpose of this Ordinance is to appropriate the amount of Six Million Pesos (PhP6,000,000.00) for the "Other Professional Services (Comprehensive Land Use Plan - CLUP)" under the budget of the Office of the City Mayor (Various Local Government Affairs) for Calendar Year 2018;

Section 2. The above-mentioned amount of Six Million Pesos (PhP6,000,000.00) shall be reverted from the "Other Professional Services (Conceptual Development Planning-CDP)" under the budget of the Office of the City Mayor (Various Local Government Affairs) for Calendar Year 2018;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.


