**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF
VARIOUS BARANGAYS IN THE CITY OF BACOOR.**

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

1. San Nicolas III – One Million Pesos (Php 1,000,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated July 27, 2018);
2. Salinas I – Two Million Pesos (Php 2,000,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated July 10, 2018);
3. Habay II – Five Hundred Thousand Pesos (Php 500,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated August 2, 2018); and
4. Habay I – Two Million Four Hundred Fifty Thousand Pesos (Php 2,450,000.00) (Please see attached Sangguniang Barangay Resolution No. 06-2018 and Appropriation Ordinance No. 03-2018 dated August 4, 2018).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of the following Barangays San Nicolas III, Salinas I, Habay II & Habay I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
