**AN ORDINANCE REALIGNING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP 400,000.00) FROM THE "MEMBERSHIP DUES AND CONTRIBUTIONS TO ORGANIZATIONS" AND "REPAIR AND MAINTENANCE- MACHINERY & EQUIPMENT" OF THE OFFICE OF THE VICE MAYOR TO THE PAYMENT OF EXPENSES TO BE INCURRED FOR "FUEL, OIL AND LUBRICANTS EXPENSES" AND REALIGNING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (PHP 250,000.00) FROM THE "INTERNET SUBSCRIPTION EXPENSES" OF THE SANGGUNIANG PANLUNGSOD TO THE PAYMENT OF EXPENSES TO BE INCURRED FOR "FUEL, OIL AND LUBRICANTS EXPENSES" COVERED BY THE ANNUAL BUDGET FOR CALENDAR YEAR 2018.**

**WHEREAS**, submitted for review and approval are the proposed realignment of funds from "Membership Dues and Contributions to Organizations" and "Repair & Maintenance- Machinery & Equipment" to "Fuel, Oil and Lubricants Expenses" in the Office of the Vice Mayor and realignment of funds from the "Internet Subscription Expenses" to "Fuel, Oil and Lubricants Expenses" in the Office of the Sangguniang Panlungsod covered by the Annual Budget for Calendar Year 2018;

**WHEREAS**, the funds to be realigned shall no longer be used by the Office of the Vice Mayor for the "Membership Dues and Contributions to Organizations" and "Repair & Maintenance- Machinery & Equipment" and the Office of the Sangguniang Panlungsod for "Internet Subscription Expenses" considering that there are sufficient available funds to finance the operating expenses of the said offices;

**WHEREAS**, there is a need to realign the total amount of Six Hundred Fifty Thousand Pesos (Php 650,000.00) from the "Membership Dues and Contributions to Organizations" and "Repair & Maintenance- Machinery & Equipment" under the Office of the Vice Mayor and from the "Internet Subscription Expenses" under the Office of the Sangguniang Panlungsod to be able to provide funds for additional program/project of the city government, to wit:

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds under the budget of the Office of the Vice Mayor from the "Membership Dues and Contributions to Organizations" and "Repair & Maintenance -Machinery & Equipment" to the payment of expenses to be incurred for "Fuel, Oil and Lubricants Expenses" and to approve the realignment of funds under the budget of the Office of the Sangguniang Panlungsod from the "Internet Subscription Expenses" to the payment of expenses to be incurred for "Fuel, Oil and Lubricants Expenses".

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of **Six Hundred Fifty Thousand Pesos (PhP650,000.00)** for the payment of expenses to be incurred for Fuel, Oil and Lubricants Expenses under the budget of the Office of the Vice Mayor and the Office of the Sangguniang Panlungsod for Calendar Year 2018;

**Section 2.** The amount **Four Hundred Thousand Pesos (PhP400,000.00)** shall be realigned from the Membership Dues and Contributions to Organizations and Repair & Maintenance- Machinery & Equipment under the budget of the Office of the Vice Mayor and the amount of **Two Hundred Fifty Thousand Pesos (PhP250,000.00)** shall be realigned from the Internet Subscription Expenses under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2018;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;
