AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY Molino IV AMOUNTING TO NINE MILLION NINE HUNDRED THIRTY THOUSAND THREE HUNDRED FIFTY TWO PESOS AND 99/100 (Php 9,932,352.99) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Molino IV in the amount of **Nine Million Nine Hundred Thirty Thousand Three Hundred Fifty Two Pesos and 99/100 (Php 9,930,352.99)**. Please see attached is the Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated August 18, 2018) provided that the approval is subject to the following conditions :

- a. Purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2017-1 dated April 26, 2017 issued by Department of Budget and management; and
- b. All other disbursement shall be subject to the usual accounting and auditing rules and regulations

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena Bautista-Mendiola duly seconded by Hon. Hernando C. Gutierrez in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod, to approve the Supplemental Appropriation of Barangay Molino IV provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance the Office of the Local Chief Executive and others concerned for their information and guidance.

ORDAINED LASTLY, this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
