AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

4. Zapote I – Two Hundred Ten Thousand Pesos (Php 210,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated September 13, 2018).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Victorio L.
