**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.**

- a. Purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2017-1 dated April 26, 2017 issued by Department of Budget and management; and
- b. All other disbursement shall be subject to the usual accounting and auditing rules and regulations.

2. Kaingen – Three Hundred Seventeen Thousand Pesos (Php 317,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated September 21, 2018).
