AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF
VARIOUS BARANGAYS IN THE CITY OF BACOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

1. Panapaan VI - Eighteen Thousand Pesos (Php 18,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated September 26, 2018) provided that the approval is subject to the following conditions prescribed in Item 9.3.4.5.1 of Manual of Position Classification and Compensation for LGUs:

. That the volunteer worker is actively performing his/her functions relative to the implementation of assigned programs and projects in the barangay;

. That the volunteer worker concerned has undergone the necessary skills and capability training which is duly recognized by appropriate authority or body either in the national or local level;

. That the amount of honoraria shall not equal nor exceed those received by the barangay officials. In case these officials are receiving the afforested minimum salary rates, the allowable honoraria for volunteer frontline workers should be adjusted accordingly so as to maintain a reasonable pay gap with the lowest paid barangay official; and

. That the grant of honoraria shall be subject to availability of funds, and budgetary limitation on personal services under RA No. 7160.

2. Mambog I - One Million Three Hundred Ninety Five Thousand Pesos (Php 1,395,000.00) (Please see attached Sangguniang Barangay Resolution No. 027-2018 and Appropriation Ordinance No. 02-2018 dated September 22, 2018).
