



AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY HABAY I AMOUNTING TO TWO MILLION FIVE HUNDRED FIFTY THOUSAND PESOS (PHP 2,550,000.00) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.
